5. To make a gift of stock or establish a workplace giving program, contact the Community Foundation of Teton Valley.

The Community Foundation of Teton Valley processes your gift, mails a tax receipt directly to you and passes along 100% of your contribution to the organizations you choose.*

Gifts accepted beginning June 1, 2018 at 9 am through July 27, 2018 at 5 pm.
