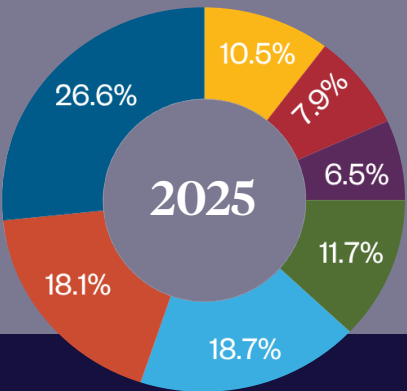

Critical Community Response — Your commitment to community ensures the Community Foundation can respond to emerging needs on an annual basis. This year, the Foundation awarded \$85,000 directly to local organizations addressing critical and ever-changing needs across all sectors of Teton Valley.



Grant in Action — ABC - Above and Beyond the Classroom was awarded \$10,000 to expand programming to include 4th-5th grade students. By providing after-school, Friday, and summer programming, ABC supports at-risk students through academic enrichment, language development, and community connection.

Instilling Philanthropy in Youth — Time, talent, and treasure are at the heart of future giving and this program for graduating seniors. Over the course of three class sessions, students engaged in insightful discussions before awarding \$10,000 to thoughtfully selected nonprofit proposals. This program provides nonprofit awareness and empowers students to make real and lasting impact in their community.

Grant in Action — PAWS of Teton Valley was awarded \$5,000 to maintain their open-intake animal shelter for lost, stray, and animals needing re-homing. They have saved over 300 local pets this year and over 1,400 since they assumed management in 2022.
